MINUTES OF THE MEETING OF THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT MEETING HELD ON FEBRUARY 8, 2021 AT 7:00 P.M. PURSUANT TO SECTION 418.016 OF THE TEXAS GOVERNMENT CODE

Pursuant to Section 418.016 of the Texas Government Code, on March 16, 2020, the Governor of the State of Texas granted the Office of the Attorney General's request for the temporary suspension of certain provisions of the Texas Open Meetings Act to allow for telephonic or videoconference meetings of governmental bodies that are accessible to the public in an effort to reduce in-person meetings that assemble large groups of people, as a precautionary measure to contain the spread of novel coronavirus COVID-19.

D. Receive Resolution 2021-05 from the City Council of the City of Jersey Village, requesting a referendum on the continuation of the Jersey Village Crime Control and Prevention District for five (5) years.

REGULAR MEETING OF THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT – February 8, 2021

City Secretary, Lorri Coody, introduced the item. She told City Council that at its January 18, 2021 City Council Meeting, the Council approved and adopted Resolution 2021-05.

The Resolution requested that the Board of Directors of the Jersey Village Crime Control and Prevention District order a referendum to be held on May 1, 2021, for the continuation of the Jersey Village Crime Control and Prevention District and the extension of a local sales and use tax for a period of five (5) years, as authorized by Subchapter F of Chapter 363, Texas Local Government Code, so that the Jersey Village Crime Control and Prevention District will be continued through the year 2026 if the continuation is approved by a majority of voters in the election held on May 1, 2021.

This item is to receive the request approved by the City Council in Resolution 2021-05.

Board President, Andrew Mitcham, announced receipt of Resolution 2021-05.

E. Consider Resolution No. 2021-01, ordering a special election to be held on May 01, 2021 for the purpose of holding a referendum on the continuation of the District and providing details relating to the holding of such election.

Board President Mitcham introduced the item. Background information is as follows:

Sec. 363.251 of the Local Government Code states that the Board of Directors of the Crime Control and Prevention District may hold a referendum on the question of whether to continue the district.

On May 2, 1998, the citizens of the City voted to establish a Crime Control and Prevention District (CCPD) within the City.

The CCPD District was continued for ten (10) years by a vote of the citizens on May 3, 2003 and again on May 11, 2013. The current District expires May 10, 2023.

Given that the City is seeking voter approval of a Fire Control Prevention and Emergency Medical Services District (FCPEMSD) during the May 1, 2021 election, the City Council of the City of Jersey Village has requested that the CCPD Board order a referendum on whether to continue the CCPD District for five (5) years so that the terms of both Districts will coincide.

This item is to call the continuation election for May 1, 2021.

With limited discussion on the matter, Board Member Warren moved to approve Resolution No. 2021-01, ordering a special election to be held on May 01, 2021 for the purpose of holding a referendum on the continuation of the District and providing details relating to the holding of such election. Board Member Singleton seconded the motion. The vote follows:



Summary of Precinct Returns - CCPD Special Election

Script

BACKGROUND INFORMATION:

The canvass is an official meeting of the canvassing authority (Crime Control and Prevention District) for the purpose of making the election results official. The duty to conduct the canvass is a mandatory, ministerial duty and not subject to the discretion of the governing body.

Pursuant to the Texas Election Code Section 67.004, the procedure for canvass is as follows:

- 1. The precinct returns shall be delivered sealed to the authority.
- 2. The authority shall open the returns and canvass them by:
 - a. preparing a tabulation stating for each candidate and/or measure
 - b. report of early voting votes by precinct;
 - c. the total number of votes received; and
 - d. the sum of the precinct totals.

A summary of this information is included for your review. Resolution No. 2021-02 indicates the votes cast for the proposition.

Once Resolution No. 2021-02 has been approved and adopted declaring the returns official, the City Secretary will send a certified copy of the Resolution to the State Comptroller.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT CANVASSING THE RETURNS OF THE SPECIAL ELECTION HELD WITHIN THE DISTRICT'S BOUNDARIES ON THE 1ST DAY OF MAY, 2021, FOR THE PURPOSE OF VOTING FOR OR AGAINST THE PROPOSITION OF WHETHER THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT SHOULD BE CONTINUED FOR FIVE YEARS AND WHETHER THE CRIME CONTROL AND PREVENTION DISTRICT SALES AND USE TAX SHOULD BE CONTINUED FOR FIVE YEARS; FINDING THAT NOTICE OF THE ELECTION WAS PROPERLY HELD AND THE RETURNS THEREOF MADE BY THE PROPER OFFICIALS IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS; DECLARING THE CONTINUATION OF THE DISTRICT; AND PROVIDING FOR THE EFFECTIVE DATE THEREOF.

WHEREAS, on February 8, 2021, the Board of Directors (the "Board") of the Jersey Village Crime Control and Prevention District (the "District") ordered a special election to be held within the District's boundaries between the hours of seven o'clock a.m. and seven o'clock p.m. on May 1, 2021, for the purposes of determining whether to continue the District and the associated sales and use tax (the "Election");

WHEREAS, on May 1, 2021, the Election was held under and pursuant to the provisions of the resolution calling the election as well as the provisions of state law;

WHEREAS, pursuant to Chapter 67 of the Texas Election Code, and Chapter 363 of the Texas Local Government Code, the Board at a meeting held on the 10th day of May, 2021, proceeded, to canvass the returns of the Election;

WHEREAS, the Election having been duly and regularly had and held according to law, and the returns thereof having been duly made and the Election Judges having certified the results of the Election, as hereinafter set out, and the Board having duly and regularly canvassed the returns of the Election and finding that the total votes cast at the Election (the "Election Returns") were as follows, to-wit:
