was adopted by City Council. These changes were made due to approval of the American Rescue Plan Grant. Therefore, we are respectfully requesting to amend the FCPEMSD's budget by increasing line item 49-26-5523 (Personnel Fire Control and Prevention District) and at the same time decreasing line item 49-26-9781 (Equipment Purchase Contribution) in the amount not to exceed \$350,000.

With limited discussion on the matter, Board Member Wubbenhorst moved to approve Resolution No. 2021-05, amending the budget of the Fire Control Prevention and Emergency Medical Services District for the fiscal year beginning October 1, 2021, and ending September 30, 2022, in the amount of \$350,000; by decreasing line item 49-26-9781 (Equipment Purchase Contribution) and increasing line item 49-26-5523 (Personnel Fire Control and Prevention District). 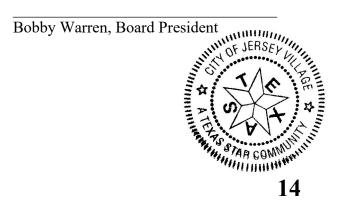
